Oktoberfest 2009 Event Sponsor Guidelines

1. Submission of application, payment in full to Statewide Towing Association and notice of approval by Oktoberfest 2009 constitutes a binding contract. Space MUST be paid in full by September 15, 2009.
2. No booth or display area will be rented without payment and signed agreement.
3. Oktoberfest 2009 reserved the right to judge the suitability of all exhibits, and shall have the right to make or request changes deemed necessary.
4. The consumption of alcohol or non-prescription drugs shall be strictly prohibited, as well as any other unlawful activities.
5. Any use of space other than what has been assigned to an Event Sponsors is prohibited. Subletting of contracted space by any Event Sponsors is also prohibited. Space assigned to an Event Sponsors shall be for their exclusive use only.
6. All exhibits will be displayed in a clean, quiet stage and orderly fashion.
7. Event Sponsors are responsible for setting up and completely dismantling their exhibits and thoroughly cleaning up their display area. Event Sponsors will be solely responsible for any damages
8. Event Sponsors are prohibited from conducting any type of lottery. Oktoberfest 2009 Committee must approve any and all give-away programs in writing.
9. Event Sponsors are required to carry their own insurance. This includes: Workers' Compensation, Personal Injury Liability and Property Damage. Execution of the exhibitor's contract acts as a waiver to any claims made against Oktoberfest 2009 Committee and the Statewide Towing Association, Inc., any of its officers, directors, members, agents or assigns.
10. Security personnel will be on the premises for general security purposes only, Oktoberfest 2009 is not responsible for the Event Sponsor's equipment merchandise or other items contained on the premises by the Event Sponsors and makes no specific commitment with regards to security of the show areas.
